#### 6. President's Address 2021

Membership numbers continue to go up despite really rough times globally, including lockdowns in Auckland and Melbourne and Sydney. Jonathan has done an amazing job organizing the conference. Antichthon goes on very well, thanks to the efforts of Bob Cowan and Diana Burton. Finances have been well managed by Tristan Taylor and Annabel Florence. Job losses at Newcastle and elsewhere. Frustrating at a time like this one. Tom Stevenson identified a lack of diversity in Classics as an important matter to be addressed. We met in March and again in November. The creation of a Diversity Officer seems like a valuable contribution. Two formal complaints have been raised according to the Code of Conduct, and an item on the agenda relates to how we manage such complaints as well as how the Code can be maintained. Tonya Rushmer has done a great job managing our communication, Kit Morrell maintains newsletters and website with endless efficiency, Phoebe Garrett has done excellent and vital work for our Society over the past several years, thanks to the executive as well for helping them to do things for the future. # 15. Revision of the ASCS Code of Conduct (Jon Hall/DO)

JH has suggested problems with the ASCS Code of Conduct and the time commitments required to participating in an investigation. Katherine Prouting asks whether the conference WHOVA chats are game but twitter 3 weeks ago is not.

Anne Mackay is worried most about the code as it stands, as it can be used by/applied by people or organizations or online forums that are not affiliated with ASCS at all. This means that there is an implication that ASCS is involved, when in fact it is not, and the Code of Conduct implementation policy hasn't been followed. We were most concerned that anything brought to the Executive would be investigated in good faith through the regular method. Rider should be attached to the code of conduct to indicate it is only used in ASCS events. JH suggests bringing specific concerns to the working group. AA indicates that we don't need the code in social media, only in ASCS contexts. SL agrees that it can only be used in ASCS events including those events that take place in an online platform of ASCS. It should not be invoked in other spaces. Trevor Evans observes that ASCS can't be everywhere. Tonya Rushmer suggests as a user of social media that things can continue to happen outside the ASCS setting; concerns around people moving into messenger type contexts where things go on, other online settings where the code might not be able to get involved/invoked/enforced. Tristan Taylor indicates that the procedures prevent any use outside ASCS formal events or activities. Anne Mackay is concerned that anyone who wants to can use it. TT suggests putting them together into a single document will cut down on these types of issues.

Tristan Taylor has offered to contribute, Janette McWilliam had offered earlier Amelia Brown proposed, Daniel Osland seconded, passed with 39 votes and 63 members
